#### 1 Features

The LSG-02 D/DE is used for extracting dust.

The LSG-02 D has an automatic level check, which stops the unit when the filter is full, while triggering the red warning light. In that case the filter has to be changed. Switching the unit off cancels the signal. The filter capacity is pre-set at the factory. The LSG-02 DE has an automatic level check and an automatic restart device. As soon as the handpiece motor is used, the extractor unit cuts in automatically. It incorporates a 20-second delay to allow for short breaks in the work process.

## 2 Safety guidelines

#### 2.2 Safety guidelines



- Configuring and operating this equipment requires precise knowledge and observance of the instructions in this service manual. The equipment is designed only for its intended application.
- Servicing and repairs should be carried out only by authorised specialists.
- Make sure that the unit is connected to the correct mains voltage.

#### 2.3 Responsibility for operation and damage

The responsibility for operating the unit lies exclusively with the owner or user if the said unit is incorrectly serviced, maintained or altered by persons not employed by an accredited dealer or if the unit is used in a manner contrary to its specified purpose.

Product responsibility lapses if the equipment is altered by unauthorized third parties or if non-original parts are installed. Use only original WASSERMANN replacement parts.

#### 3 Application

The LSG-02 D/DE extractor drawers are technically proven and solid items of equipment made entirely of metal. Once pulled out, the drawers switch on automatically as soon as you start work. If a finishing motor is attached to the extractor, it starts as soon as the drawer is pulled out. This connection automatically switches the handpiece motor off again as soon as the drawer is pushed in. Working without dust extraction is not possible with this configuration.

Only use the device for this type of application.

#### 4 Before starting

#### 4.1 Transport

Before transporting the unit, ensure that it has been unplugged from the power socket. Make sure that it is packed correctly in order to avoid accidental damage.

Be sure to check for any transport damage when unpacking the goods. Note down any damage if found.



#### 4.2 Installation

Open the box, remove the packing materials, and carefully lift out the device and accessories. Check the included accessories.

Do not install the unit outdoors or in places without proper ventilation.

Before start-up, be sure the device reaches room temperature.

## 4.3 Storage

If the unit is to be stored for an extended period, protect it from moisture and dust.

#### 5 Start-up / Installation\_

#### 5.1 Assembly

To install the unit, first undo the red safety screws on the left and right of the frame until the frame can be removed from the extractor drawer.

Attach the drawer to the table plate. The front screw hole should be 110 mm from the front edge of the plate. Fasten the frame with 4 x M5 metal screws or 5 mm strong wood screws. Then locate the drawer on the telescopic rails. Tighten the red safety screws again to limit the outward travel of the drawer.

#### 6 Operation

Connect the drawer to mains power.

- 1. Press the (green) rocker switch.
- 2. A microswitch starts the extractor and any attached finishing motor as soon as the draw is pulled out.
- Switch the unit off if it will not be used for an extended period.



### 6.1 How to set the automatic switch-on facility of LSG-02 DE

- 1.) Pull the drawer completly out of the mounting frame. On the upper site of the unit there is a plastic blank plug, under which the potentiometer for setting is situated.
- 2.) Switch on the Suction-drawer, switch on the Automatic-starting.
- 3.) Turn the potentiometer with the help of a little screwdriver very slowly anti-clockwise until it blocks.
- 4.) Let motor run, a little higher than lowest speed, recommended speed 5.000 min<sup>-1</sup>
- 5.) Turn the potentiometer very slowly and carefully clockwise up to that point the suction unit starts.
- 6.) Setting is finished.

#### 7 Troubleshooting

#### 7.1 LSG-02 D

Fault	Cause	Remedy
Filter saturation - red light comes on		Change filter or switch to continuous operation
Green rocker switch comes on but nothing happens	Faulty mains switch	Mains switch must be replaced

#### 7.2 LSG-02 DE

Fault	Cause	Remedy
Filter saturation - red light comes on	Filter full	Change filter or switch to continuous operation
Green rocker switch comes on but nothing happens	Faulty mains switch	Mains switch must be replaced
No control from micromotor	Trim potentiometer not adjusted	Adjust trim potentiometer to match model

#### 8 Care and maintenance

#### 8.1 Cleaning



Disconnect the power plug before starting any maintenance work.

The identification plate must always be kept in easily legible condition and must not be removed.

The equipment should be cleaned at regular intervals to ensure trouble-free operation.

It requires only normal cleaning (sponge, damp cloth, mild detergent) - no chemical additives.

Use only cold cleaners to avoid damaging the paintwork or removing the lettering.

#### 8.2 Maintenance

Filter change (optical display when filter change required).
In spite of changing the filter if required the LSG-02 D / LSG-02 DE does not require any servicing. Just make sure that the device is kept clean.

#### 8.3 Warranty

i

The warranty period for our equipment is 12 months. If faults occur within the warranty period, contact your dental depot or get in touch directly with our service department.

Your equipment should only be operated in perfect condition. If faults occur which could harm operators or third parties, the unit should not be used until it has been fixed.

This warranty does not cover damage caused by improper use, external mechanical causes, transport damage or interference with the unit by unauthorized persons.






## 11 Wiring diagram LSG-02 D






## 12 Wiring diagram LSG-02 DE
